

You are requested to take necessary steps to ensure blocking access of pornographic contents on Internet by the students and staff of Jawahar Navodaya Vidyalayas of your region. The following guidelines are issued for necessary adherence.

- Counseling of students may be done through male & female teachers.
- To conduct special workshops in every JNV for awareness of sex education.
- To create the safer environment through the promotion of hotlines, encouraging self-regulations and codes of conduct, developing, filtering and rating systems, creating awareness among parents, teachers and children.
- To install Parental control filters/firewall for curbing online pornography and undesirable contents and also to develop syllabus to cover issues of cyber security and cyber safety including prevention of pornography on internet. In this regard, necessary assistance may be taken from PGT (Computer Science) and FCSA.

The action taken report on the subject and adherence of instructions being issued therein may be submitted at the earliest.
